

## ZENITH BOARDING RESIDENTIAL AGREEMENT

ACCOMMODATIONS

The following rules and regulations have been established not to limit the freedoms of our residents, but instead to secure their freedoms by creating a mutual understanding. Persons residing at any Zenith related property are bound by this Residential Agreement & our Zenith Boarding Protocol. Residents are required to sign or update their agreement each residential year or access most recent updates online:

- ✓ You are required to respect the boundary areas and privacy of each person.
- ✓ The Landlords insurance does not cover personal losses. Residents should take precautions to protect personal belongings from theft, fire, water damage, or other loss. Individual insurance policies protecting personal possessions are the sole responsibility of the resident should you wish to provide for such contingencies.
- ✓ Residents are expected to utilize the 'Resident pHub' to show proof of rent and utility bills monthly
- ✓ Allow Zenith Management staff to check the room quarterly.
- ✓ Cooking in the room is prohibited and should only be done in the kitchen area
- The display of sexual behaviour that would be reasonably offensive to others is **strictly prohibited**; including conduct that creates an intimidating, hostile/offensive environment for another person
- ✓ No pets are allowed on the premises in any form
- ✓ Do not take or consume other people's food or beverages
- ✓ Theft of any kind or possession of stolen property is strictly prohibited.
- $\checkmark$  All trash and garbage must be emptied regularly prior to creating an unsanitary condition.
- ✓ No microwaves/toaster ovens, refrigerators or hot plates are allowed in rooms.
- ✓ Smoking of any kind including tobacco and cigarettes are **strictly prohibited** on the property.
- ✓ The use or possession of illegal drugs, narcotics, or hallucinatory agents on the property is prohibited. Any PERSON suspected of possessing or selling drugs or narcotics, possession, or sale of drugs or narcotics shall be disciplined according to the law and evicted from housing. Any drug residue or paraphernalia found in rooms is also sufficient evidence for eviction/legal action.
- ✓ Be considerate. Please do not turn your TV or stereo volume where it may affect the wellbeing of your neighbours. Excessive noise is strictly prohibited!! Respect the rest of others **DAY or NIGHT**!
- All occupants should be tolerant, considerate and respect each other at all times. There should be no use of vulgar and abusive language and use of force (fighting) or any unruly behavior towards one another. First offence of this may warrant an eviction.
- As best as possible all occupants should avoid "overcrowding" their rooms. No visitors are allowed to stay beyond **MIDNIGHT** without the expressed knowledge of the property manager.
- ✓ Tenants will neither use nor permit the use of their residential spaces for any purpose other than their own private dwelling and shall not conduct any commercial activity from the location.
- ✓ Flammable liquids such as candles, gasoline, turpentine, or oils will not be allowed in rooms.
- ✓ Nailing, drilling or any fittings to the walls, ceilings or any part of the room is strictly prohibited. The resident(s) of the room shall be responsible for any damage caused.
- Furniture assigned to the rented space and accessories including bedskirts, mattress protectors and curtains must remain in the room and maintained in fair condition without damage.
- ✓ Any problems concerning your stay must be promptly communicated using the "Resident pHub" portal, or to the resident advisor in writing using the medium outlined in the Zenith Boarding Protocol.
- Residents are required to limit visitors and are subject to household consent during the pandemic. <u>All protocols</u> are to be observed; this includes wearing of masks, sanitizing and ensuring social distancing.
